Survey Name: Wyoming Game & Fish Commission Data Request

Survey Description: The Wyoming Game & Fish is in the process of reviewing the assessed value of the Commission owned property around the State. They indicated that they have seen large differences in the estimated fair market values over the last year ranging from 4.2% to 134.37%. The Commission's concern is not centered on the possible market increase in some counties, but ensuring the information in the records is complete. Subsequently, the Game & Fish Commission is requesting a CAMA down containing County Name, Land Type, Total Acres or SQFT per account, Account Number and abstract number. Note, the Commission property is assessed under the special tax levy described in W.S. 39-13-103(b)(xii)(A) and (B).
